the Plaintiff had asked that FACEBOOK, & GOOGLE be given an order to provide the available information. Judge Rudofsky chose to hold in abeyance the ORDER request for FACEBOOK AND GOOGLE.


ORDER granting in part and holding in abeyance in part 24 Mr. Ward's service-related requests; ordering Defendants Randall, Turner, Trevathan, Morris, Morrison, Copenhaver, Rogers, Moore, and Duncan to each separately provide written answers to the questions in this order; holding in abeyance the remainder of Plaintiff's service-related requests until defendants respond; and extending the time to serve the Defendant who is going by the alias Simrit Kaur to 90 days from the date of this Order. The Court repeats its invitation to Mr. Ward to ask the Court for the appointment of pro bono counsel to represent him. Signed by Judge Lee P. Rudofsky on 04/15/2024. 2. The Plaintiff requests at this time for the ORDER be issued to GOOGLE and FACEBOOK for ALL items requested in his PROPOSED ORDER so that we can discover who Simrit Kaur is so she can be served.
3. The Plaintiff also asks this Court to hold Kimberly Randall, Wannda Turner, Stan Morris, and Melissa Morrison in contempt and issue a warrant for their arrest so that they can be held until they answer Judge Rudofsky's ORDER

from 04/15/2024 plus additional time for refusing to answer the ORDER in the time specified.

4. The Plaintiff notified each Defendant on 04/15/2024 about the ORDER as at that time the Plaintiff only had 30 days to serve Defendant Simrit Kaur.
5. The Plaintiff spoke with Defendant Carol Duncan and she stated that Larry Copenhaver, Larry Rogers, Jeffrey Moore and herself truly did not know the identity of Defendant Simrit Kaur.
