Narrative & Statements

Narrative - Talley, Michael - 7/17/2021 (Initial)

On 7/17/21 While assisting Inv Smith at a traffic stop I made contact with Arrestee #1 (Gibson, Brandon). Smith attempted to place Arrestee #1 (Gibson, Brandon) into custody and Arrestee #1 (Gibson, Brandon) began tensing and pulling his arms away from handcuffs. Arrestee #1 (Gibson, Brandon) was warned several times by myself and Smith, at this point i deployed my X2 taser and the suspect fell to the ground and was placed into custody.

Arrestee #1 (Gibson, Brandon) was transported to CCDC where he was left in there custody with a court date of 7/19/21 at 1300 and cited for the listed charges and a \$2,015 C/S bond

Narrative - Smith, Dustin - 7/17/2021 (Initial)

On 07/17/2021 I was traveling southbound on Scott St. at the intersection of Scott St. and Belt St. I saw a gray Tahoe lifted with after market blue lights under the fender well approaching the four way stop intersection from the West on Belt. The gray tahoe ran the four way stop sign into the intersection then stopped in the intersection and continued on eastbound onto Belt. St. I initiated a traffic stop on the vehicle on Belt St. just East of the intersection with Scott St. The Tahoe continued onto State Street southbound and came to a stop in front of 521 State St. I made contact with the black male driver and advised him the reason for the stop and my name. The black male driver handed me a Texas drivers license and his insurance paperwork. I ran the Texas drivers license and it returned to Arrestee #1 (Gibson, Brandon) name and date of birth but advised it belonged to a female and had no picture. I also located an Arkansas return for Arrestee #1 (Gibson, Brandon) and it showed that he had a suspended drivers license through Arkansas. Dispatch advised at this time that Arrestee #1 (Gibson, Brandon) had valid warrants through our department and the eastern district of Craighead County.

I returned to the vehicle at this time and advised Arrestee #1 (Gibson, Brandon) to step out of the vehicle. Arrestee #1 (Gibson, Brandon) was on the phone with someone and very slowly complied. I told Arrestee #1 (Gibson, Brandon) to place his hands behind his back and that he was under arrest for a warrant. Arrestee #1 (Gibson, Brandon) refused to put his hands behind his back and when I grabbed his wrists he began to pull his wrists back toward the front of his body. Investigator Talley at this time attempted to help me pull Arrestee #1 (Gibson, Brandon) wrists behind his back. I repeated commands to Arrestee #1 (Gibson, Brandon) to stop resisting and place his hands behind his back but he would not comply. Investigator Talley then advised me to disengage that he was going to deploy his taser. I heard Inv. Talley tell Arrestee #1 (Gibson, Brandon) to put his hands behind his back or he would be tased but he would not comply. Inv. Talley then deployed his taser and Arrestee #1 (Gibson, Brandon) fell to the ground with myself partially catching him before he came in contact with the street. I was then able to place Arrestee #1 (Gibson, Brandon) into handcuffs. While Arrestee #1 (Gibson, Brandon) was still on the ground I removed the taser probes from his back. Arrestee #1 (Gibson, Brandon) was then placed into the back of Inv. Talley's patrol vehicle and transported to the Craighead County Detention Center.

Arrestee #1 (Gibson, Brandon) vehicle was inventoried per department policy. During the inventory i could see that the radio had been pulled out. Behind the radio I located Arrestee #1 (Gibson, Brandon) Arkansas drivers license as if he were attempting to hide it from discovery. Arrestee #1 (Gibson, Brandon) was towed from the scene by DD towing.

While at CCDC Arrestee #1 (Gibson, Brandon) was cited on ticket number 1A08423845 for drivers license suspended and resisting arrest and served on his valid warrant JO-21-1337. Arrestee #1 (Gibson, Brandon) was given a court date of 07/19/21 and left in lieu of a \$2015.00 c/s bond.
