On 1-14-2023 I was dispatched to the address of [REDACTED]. I was dispatched to the address for a welfare check on an Ashley Shannon. The address that I was dispatched to was the wrong address and the person that I was looking for was at the address next door at Dustin Shannon's mother's residence. I was informed this by Travis Davis who came to me and stated I attempted to make contact with Ashley Shannon at the wrong address.

As I approached the residence Mrs. Shannon was standing at the door of the home. I made contact with Mrs. Shannon and a Dustin Shannon. Mrs. Shannon stated to me that she was just about to exit the door when I pulled up. I then asked Mrs. Shannon to step outside and talk to me. Mrs. Shannon agreed to do so and we stepped outside from Mr. Shannon. I asked Mrs. Shannon what was going on and asked if she was being held against her will. Mrs. Shannon stated that she was there trying to get her children. It should be noted that there is an ongoing custody battle between Mr. Shannon and Mrs. Shannon. I then informed Mrs. Shannon that other parties were concerned for her well being and thought she was being held at the residence against her will. Mrs. Shannon stated again that she was just about to leave when I arrived at the residence.

I then left the residence and stopped at the residence of [REDACTED]. I informed Travis Davis and his wife that Mrs. Shannon remained at the residence on her own free will and was leaving shortly. I then left the residence and traveled a short distance and was called back to the residence I was just at. I was called back to the residence in regards to an altercation between Travis Davis and Dustin Shannon. When I arrived both parties had a hold of one another. The two parties had a hold of one another's clothing. I then separated both parties and detained them. Both parties were claiming that they felt threatened by the other's actions. Mr. Shannon felt threatened because when he approached Davis by opening the door to his SUV, he had his hand on his pistol that was in his waistband. Davis stated that Shannon began to swing punches at him and strike him. I did not see any markings on Travis. I did notice that Mr. Shannon was bleeding from his forehead. Mr. Shannon stated that he was not struck by Travis and that the injury happened because he slipped and fell into the open door of the SUV. Shannon stated that the injury was not caused by Travis but that Travis did grab him by his throat. I did not see any markings to the neck of Mr. Shannon. Mr. Shannon told me that he has told Travis Davis to not come onto his property many times because he was not welcomed. Mr. Shannon stated to me that he has told Travis Davis multiple times to not be on his property.

I then notified my Sergeant, Sgt. Dillon Pigue of the situation that had occurred. It was then determined that Travis Davis was on the property uninvited and that he was told that he was not welcomed on the property. Travis Davis was arrested and transported to the Poinsett County Detention Center for Criminal Trespassing. Davis was arrested and transported by Deputy Bowman to the Poinsett County Detention Center without incident. Travis Davis was issued citation # 383563 for Criminal Trespassing. Travis Davis was issued a court date to appear in the District Court of Harrisburg on 2-21-23. Travis Davis was given an affidavit and informed of the process. At this time I have nothing further.
