On August 9, 2024, Joseph Harris responded to assist in locating, detaining, and transporting an individual escaped from St. Bernards. During transport, the individual attempted to strangle himself with the restraint belt in the back of Harris' vehicle. Harris stopped his vehicle and made contact with the individual who had the belt around his neck and was on his back in an offensive position. Upon making contact with the individual, Harris struck him in the head several times with his fist and then with his elbow before removing the belt from his neck. Harris then slams the door closed which strikes the individual in the head. The individual then ceases to move and respond. Harris used his baton to rub the individual's sternum in a forceful manner which causes the individual to respond. Harris then again slams the door on the individual's head. The incident was recorded by Harris' in vehicle camera as well as witnessed by an assisting officer. While at the jail, Harris attempted to strike the individual while he was handcuffed. Harris was terminated on August 9, 2024, for the excessive use of force. This is a violation of Rule 1034(1)(b)(iii), (viii), (vii), and Rule 1020. Jonesboro Police Department recommends decertification.

NARRATIVE: On August 9, 2024, Joseph Harris responded to assist in locating, detaining, and transporting an individual escaped from St. Bernards. Harris stopped his vehicle and made contact with the individual who had the belt around his neck and was on his back in an offensive position. Upon making contact with the individual, Harris struck him in the head several times with his fist and then with his elbow before removing the belt from his neck. Harris then slams the door closed which strikes the individual in the head. The individual then ceases to move and respond. Harris used his baton to rub the individual's sternum in a forceful manner which causes the individual to respond. Harris then again slams the door on the individual's head. The incident was recorded by Harris' in vehicle camera as well as witnessed by an assisting officer. While at the jail, Harris attempted to strike the individual while he was handcuffed. Harris was terminated on August 9, 2024, for the excessive use of force.

This is a violation of Rule 1034(1)(b)(iii), (viii), (vii), and Rule 1020.

RECOMMENDATION: Jonesboro Police Department recommends decertification.



Allegation of Excessive Force

08/08/2024

Complaint Summary

At around 0850 hours on 08/09/2024 I received a call from Craighead County Captain Ron Richardson concerning an incident involving JPD Officer Joseph Tucker Harris. Richardson said he had received information from Deputy Ditto concerning the force Harris used against Coram during a prisoner transport.

Richardson said Billy Coram escaped custody from a deputy while at St. Bernards and Harris responded to the area where Coram was located. Harris assisted in taking Coram into custody and then began transporting Coram to the jail. During the transport, Coram attempted to strangle himself with the restraint belt in the back of Harris' vehicle. When this happened, Harris and Deputy Ditto stopped their vehicles to help Coram. Richardson said Deputy Ditto had concerns about Harris using excessive force when dealing with Coram and asked me to review any video JPD may have.

Captain Richardson said there was also video from the jail which shows continued interaction between Harris and Coram inside the booking area.

A short time later, Captain Ron Richardson and Craighead County Investigator David Bailey came to my office, viewed rear seat camera footage from Harris' vehicle and also gave me copies of the video footage they possessed.

Inquiry

I viewed the video from Harris' vehicle and asked Chief Elliott and Assistant Chief Lynn Waterworth to also view the video.

Shortly after viewing the video, Chief Elliott ordered that Officer Harris be placed on administrative leave until the incident could be fully investigated. A.C. Waterworth called Officer Harris twice and left a message for him to call her back. I prepared an Administrative Leave form and a Complaint Notification form for Officer Harris to sign when he responded. When he did not answer the phone, Captain Chambers went to Harris' residence to try and contact him but was unsuccessful.

Upon review of the camera footage from the rear of Officer Harris vehicle, it is clear Coram uses the restraint belt system to strangle himself as he is being transported to the Craighead County Jail. While close to the jail on Willett Road, Officer Harris stopped his patrol vehicle and opened the rear driver's side of the vehicle to access Coram, who had a belt around his neck, is on his back, has his foot against the roof of the vehicle, and his head slightly turned toward the rear of the vehicle.

Shortly after accessing Coram, Officer Harris struck Coram in the head several times with his fist and then several more times with his elbow, and pushing Coram's leg down before removing the restraints from his neck. As this is happening, a deputy can be seen opening the rear passenger door and assisting Harris with Coram.

After removing the restraints from Mr. Coram's neck, Officer Harris slammed the patrol vehicle door closed, striking Coram in the top of his head. After that happened, Deputy Ditto began to try and get Coram, who didn't appear to be moving, to respond by asking if he was "all right" and pushing his legs back into the vehicle before closing the door, radioing dispatch, and moving around to Harris' position. A few seconds later, Officer Harris opened the rear driver's door again and when Coram did not respond, Harris used his ASP expandable baton to rub Coram's sternum in a very forceful manner. After this action, Coram began to groan and raise up from a lying position. As he did that, Harris again slammed the car door on Coram's head.


Deputy Ditto's body worn camera was also reviewed. Ditto can be seen stopping to help Officer Harris on Willett Road. He at first ran to the side of the officer and then around to the passenger side to help with Coram.

Billy Coram was then transported to the jail where he was removed from the vehicle by jail staff. At the jail, Coram was cursing and very resistive to jail personnel. As they attempted to control him and get a restraint chair ready, Officer Harris came into the booking area with the group. During this time, Coram moved toward Harris while still handcuffed. When he did this, Harris attempted to strike him with his left hand. When this happened, the jail staff put his arm out and told Harris to stay back. After, Harris moved away from the area and the jail staff eventually placed Coram in a restraint chair.

Findings

On 08/09/2024, after reviewing this video associated with this complaint, I notified Assistant Chief Lynn Waterworth, who in turn notified Chief Rick Elliott. After Chief Elliott's review of the video evidence, he instructed me to have Officer Harris meet with him in his office as soon as possible. At around 1600 hours, Officer Harris came to Chief Elliott's office where Chief Elliott terminated his employment for using excessive force.

The allegation of Excessive Force against Officer Harris is sustained.
