PROBABLE CAUSE AFFIDAVIT

Accused Party or Parties: Casey, Cameron Tyler

The undersigned affiant gives the statement of facts recited herein as being true to the best of his or her knowledge and belief and submits such statement of facts in support of probable cause for detention to be considered by the judicial officer conducting the pretrial release inquiry:

On December 30, 2025, the Craighead County Sheriff's Office Criminal Investigation Division received a copy of a Lake City Police report in reference to a dog being shot by one of Lake City's employees. The Sheriff's Office was asked to assist in the investigation. An interview were conducted with Brian Bass, the complainant listed on the Lake City Police report number 25-00138. The report stated that on December 22, 2025, Lake City Animal Control Officer, Cameron Casey, advised he had received complaints about an alleged aggressive dog at large in the city. Casey told Lake City Police that he attempted to utilize a dart gun in an attempt to capture the dog, but was unsuccessful in the attempt. Casey told Police that the dog charged him at which time he shot the dog, with a gun, in an attempt to defend himself.

Body camera footage was sought from the Lake City Police Department pertaining to the incident and Casey can be seen and heard on the footage denying that he shot the dog. While investigating the alleged incident, it was learned that on October 2, 2025, Casey was allegedly involved in another incident in his capacity as dog catcher, where Casey was asked to assist with a dog owned by Tyler Crump, getting out. Casey can be seen and heard on video, attempting to take possession of the dog, which appeared to bite Casey on the hand after Casey abruptly grabbed the dog. Casey dropped the dog, a small breed Chihuahua named Hank, to the concrete area and kicked the dog a lengthy distance across the yard from what appeared to be frustration. Hank could be seen flipping head over heels through the air prior to hitting the ground and rolling over before he could get to his feet and run from Casey. Hank never was able to return home as he was allegedly ran over by a vehicle sometime shortly after the kicking incident occurred.

During the investigation, it was revealed that Mr. Casey had an active warrants out for his arrest. Craighead County Deputy Sheriff's located and arrested Cameron Casey in reference to the warrants and Mr. Casey was

transported to the Craighead County Sheriff's Detention Center to await pickup from Baxter County on the warrants.

A criminal investigator for the Sheriff's Office interviewed Mr. Casey while he was at the Sheriff's office. After being read his Miranda Rights, Casey confirmed that he was employed by the city of Lake City as a dog catcher / animal control officer / sanitation worker. Casey stated that he had completed training and was supplied with appropriate equipment by the city to Lake City to perform work and duties of animal control officer. Casey stated that on December 22, 2025, he was going to the area of a ditch located in the city to set a trap in an attempt to catch stray dogs that hung out in the ditch area. Casey stated that the dogs normally would run from him but that they did not run on this occasion. Casey stated that he turned around and the dogs had aggressed towards him, at which time he shot a single shot from the .22 caliber rifle in an attempt to scare the dogs off. Casey stated he did not mean to hit a dog but that he unfortunately shot a dog known to Brian Bass as Cujo. Casey stated the dogs ran off and he later located it in the yard area of Brian Bass residence at which time he took possession of the dog to euthanize it. Casey stated that he did not have a tranquilizer dart gun with him and only had the rifle at the time of the incident. In the Lake City Police report, Casey allegedly told Police that he attempted to shoot the dog first with a dart gun before shooting the dog with the .22 caliber rifle.

Casey was asked about the alleged incident on October 2, 2025 involving the Chihuahua named Hank. Casey stated that the dogs owner had contacted Lake City to see if they could assist with catching Hank until someone could get there to take possession of the dog. Casey told this Detective that he did not take the proper equipment, such as gloves, leash or catch pole when he went to the house to catch the dog. Casey stated that he pulled up at the residence and saw the dog, Hank sitting on the front porch area of the residence. Casey stated that he had been told to go scoop the dog up and take it home with him until the owner returned because he was not going to put a little dog like that in the pound. Casey said that he hollered for the dog when he arrived and could not get the dog to come to him. Casey stated that he and the dog went around to the back of the residence and he tried playing with the dog to get him to come to him and that he messed up and picked the dog up. Casey said the dog turned his head and bit his hand at which time he dropped him and shoed him away. Casey stated that he messed up, made a bad mistake and then reacted and it was arrogant of him to think he could just pick up someone else's dog. Casey stated that he handled the situation poorly, that he wasn't trying to hurt the dog, and that he just made a mistake. Casey stated that he wasn't frustrated after being bit, that he was a 6 foot tall 180

8 pound man and the dog was a 8 pound Chihuahua, that any kind of brush was going to roll him and it was not like he intended to just launch the dog.

Due to the information obtained throughout the investigation, a warrant for Cameron Caseys' arrest is being sought for two counts of animal cruelty and one count of filing a false police report in reference to information supplied to the Lake City Police on report number 25-00138.

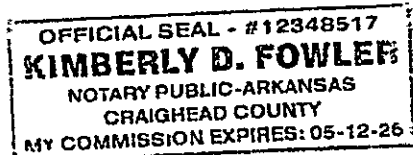


