In light of recent events, I have concluded that legal action is necessary to stop the harassment of myself and my family by the "The City of Trumann, Arkansas Just for Fun" Facebook page, "Citizens for a Better Trumann" Facebook page, "The Arkansas Justice Project" Facebook page, Heather Shrader, Michael McWayne, and C.J. Laire. The individuals posting on these anonymous Facebook pages knowingly encrypt their identity to aid, assist, or encourage another person to commit any criminal offense and directly violate A.R. Code 5-41-204 (2019). The above individuals and pages are responsible for immeasurable emotional damage to my family and me. Their actions have caused physical damage to my property, as well as irreversible damage to my character and professional career.

Furthermore, Heather Shrader has continually harassed my family and me to the point that I believe it has become stalking. A.R. Code 5-71-229. Stalking (c) states, "A person commits stalking in the third degree if he or she knowingly commits an act that would place a reasonable person in the victim's position under emotional distress and in fear for his or her safety or a third person's safety." This harassment has occurred monthly for several years. Prosecuting attorney Thomas W. Haynes issued a letter to Heather Shrader to cease harassing communication per A.R. Code 5-71-209 in 2020. Heather has not only continued this harassing communication under the protection of anonymity but now has inserted herself directly into my personal life with false allegations against my family and me through a third party in direct violation of attorney Haynes's order. In fact, Heather attempted to use a forged affidavit document against me that The Trumann Police Department rejected.

"The City of Trumann, Arkansas Just for Fun" Facebook page administrators have continually harassed my family and me for 4 or 5 years. They have requested citizens to photograph my private property, edited pictures to depict me in an obscene manner, made videos depicting private citizens (my wife included) as Nazis, used obscene, lewd, and profane language against private citizens, and harassed public officials, city employees, and private citizens under the guise of anonymity and with the intent to cause emotional or physical damage. I believe Michael McWayne and Heather Shrader administrate this page. If Michael McWayne and Heather Shrader are not the administrators, then they are absolutely feeding this page false information with the intent to cause emotional and physical harm to my family and me. Also, in direct violation of Attorney Haynes's order.

Heather Shrader administrates the "Citizens for a Better Trumann" Facebook page, a known fact. This page has worked hand in hand with "The City of Trumann, Arkansas Just for Fun" and "Arkansas Justice Project" Facebook pages. Because Heather is the administrator and continually harasses my family and me through a third party, she directly violates Attorney Haynes's order. This fact further proves the intent to cause emotional and physical damage to my family and me under the guise of anonymity.

"The Arkansas Justice Project" Facebook page recently posted an article accusing me of using city property in an unapproved manner and even using bogus mileage numbers as a fact. They have also requested for people to follow me around and take videos. The misuse of property and mileage is entirely false. They interviewed with Region 8 News with completely false information and Bruce Ellis Taylor slandered my name on live television. They did so with malice and without any evidence whatsoever. It was a made-up story to cause emotional damage to me personally and character damage to me professionally. This story's damage is detrimental and irreversible to my future and career as a professional.

C.J. Laire has been following me for multiple years. He has made multiple Facebook posts and posted comments proving such. He has also published comments about which vehicle I parked in my carport, and he has followed me on occasion while I was in my personal vehicle. Yesterday afternoon, February 14, 2023, at approximately 10:00 am, C.J. Laire made a U-turn on Hwy 463 near Daily Dose Pharmacy and followed the Fire Department through the city. He then drove by several times while firefighters were performing their required physical fitness regimen at the gym. After work, I came home and switched to my personal vehicle to pick up my son from school. C.J. Laire then followed me while I was off-duty and in my personal vehicle to the school. After picking my son up, he followed me home and turned around on Reed Street near my house. This is an escalation from recent incidents. On March 5, 2020, my wife was blocked in our driveway by a parked vehicle. The person was there as a result of "The City of Trumann, Arkansas Just for Fun" Facebook page's request to photograph public officials' property. This person blocked my wife from leaving, causing her to fear for her safety, and a police report was filed. My personal vehicle was keyed, scratched, and had a sign hammered into the tire. I also filed a police report with the Poinsett County Sheriff's office for this incident. Police Chief Chad Henson was followed home by Johnny Kelley less than five years ago. That citizen then attempted to shoot and kill Chief Henson shortly after. These incidents have made me fear for my family and my safety.

I am filing this criminal affidavit against the above parties for harassment, stalking, and other crimes that you may see fit against my wife and me. It is not the victim's duty to investigate the crimes committed against them, nor does a victim have the means to investigate cybercrimes. There are thousands of comments and posts that I cannot screenshot or gain access to because I have blocked the individuals from my Facebook account in an effort to stop the attacks. I have provided several documents as evidence to best of my ability. The evidence provided will show the connection between the parties, fist hand admitters of administrators of the Facebook pages, prosecuting attorney cease and desist documents, and an attorney admitting that Heather was "Hellbent and a little too personally involved". These documents also show that the actions of the administrators of those pages have intentionally caused other individuals to commit crimes against my family and me.

The crimes that have occurred have escalated rapidly over the last few months, and I expect a full investigation into these crimes and their anonymous nature.

Dear Mrs. Schrader and Mrs. Kemper:

I am writing to inform you that I have reviewed the affidavits submitted by both of you against the other, and that based upon my review, I have not approved the filing of criminal charges against either of you at this time. I am not presently convinced that the allegations have arisen to the level to justify criminal charges.

Having said that, I want you to know that I take every affidavit that is submitted to me seriously, and I have a strong desire for the City to operate as orderly, peacefully, and professionally as possible. To that end, I would encourage both of you to cease contact with one another.

Although I am not inclined to approve criminal charges at this time, please know that subsequent affidavits submitted to me with additional allegations could lead to a different result after this letter. I would especially be looking at Harassing Communications Ark. Code Ann. § 5-71-209, which may be proven in the event that a person engages in certain types of contact with the purpose to "harass, annoy, or alarm another person." Further contact of similar nature occurring after receipt of this letter may be evidence of an intent to harass, annoy, or alarm.

Please note that by authoring this letter I am not weighing in on whether one of you has more culpability here or not. The purpose of this letter is to solely inform you that neither affidavit reaches the level of being able to sustain a criminal charge against the other, but that further contact and subsequent affidavits could lead to a different result.

I am hopeful that this issue can be resolved without further court involvement.

## Narrative & Statements

### Narrative - Dye, Grayson - 3/5/2020 (Initial)

On 3/5/2020 at approximately 1047hrs I was dispatched to the Trumann Police Department in reference to a complainant at the window. Upon arrival, I made contact with the complainant, Beth Kemper. Kemper advised that she was trying to leave her house when she noticed a white Kia Soul parked on the road in front of her house halfway blocking her driveway. She stated she had to honk at the vehicle multiple times before it finally moved. Kemper stated that she observed a male she believed to be Kelly "DJ" Walters driving the vehicle. She stated that she has known DJ for a while and that she knew he drove a Kia Soul. Kemper stated that the vehicle then drove into her yard to turn around. She stated she believed that Walters was taking pictures of the residence. Kemper stated that the actions of this vehicle made her very uncomfortable.

Kemper filled out a witness statement form which is attached to this report.
