**PROBABLE CAUSE AFFIDAVIT**

Accused Party or Parties: Sanders, Jackie L

The undersigned affiant gives the statement of facts recited herein as being true to the best of his or her knowledge and belief and submits such statement of facts in support of probable cause for detention to be considered by the judicial officer conducting the pretrial release inquiry:

In February of 2023 I, Capt. Lenny Becker with the Trumann Police Department was assigned RPS Case #23-00140. The case was reported to the Trumann Police Department by Mr. Revis Kemper and his wife Beth Kemper. The Kemper's had filed an affidavit advising that they have been the victim of continuous harassment and cyberbullying due to some Facebook pages that are being run by anonymous suspects (see victims statement). The case involves two Facebook Pages (The City of Trumann, Arkansas "just for fun," and Citizens for a Better Trumann). I obtained Search Warrants for these Facebook Pages. It was discovered that the harassment was from James Wayne Hickey aka Bo Hickey, Jackie L Sanders, Heather Shrader, and Brandon Shrader.

**Citizens for better Trumann:**

After receiving all the information presented by Mr. Kemper it was discovered The Citizens for Better Truman page is run by Heather Shrader. I did file for and obtain a search warrant for this page. The page was created on January 20, 2020. In a Letter that was presented to former Chief of Police Chad Henson from Asa King he advised that he had stated the Facebook Page about Trumann and later made Heather Shrader an administrator of the page. Asa stated in the letter that "Little did I know the firestorm that my old friend Heather Shrader had become, and the mayhem that would ensue". He advised that Heather had called him after she went to the Trumann Fire Station and that Asa told her that she was getting in this a little too deep. Asa also stated in the letter that he thinks that she got a little hellbent and a little too personally involved. He advises that he attempted to talk with Heather and refocus the efforts on making things better for Trumann and not picking fights with people. As of the date of the statement the page under the name Citizens for Better Trumann is operated by Heather Shrader.

**The City of Trumann, Arkansas:**

After receiving information on the second page The City of Trumann, Arkansas, It was discovered that this Facebook page was created on March 09, 2019 with an email address of [c\\_justin76@yahoo.com](mailto:c_justin76@yahoo.com) [<mailto:c\\_justin76@yahoo.com>](mailto:c_justin76@yahoo.com), vanity name of case.justin.71.

I was able to obtain and search warrant for the yahoo email account of [c\\_justin76@yahoo.com](mailto:c_justin76@yahoo.com) [<mailto:c\\_justin76@yahoo.com>](mailto:c_justin76@yahoo.com), and after receiving the data back it was learned that the email belongs to James Wayne Hickey aka Bo Hickey who is on the Chamber of Commerce in Trumann and also owner operator of Delta EMS and Fire text. Mr. Hickey was also formerly employed by the Trumann Fire Department before his resignation. Mr. Hickey was the creator of "The City of Trumann, Arkansas". He used the email of [c\\_justin76@yahoo.com](mailto:c_justin76@yahoo.com) [<mailto:c\\_justin76@yahoo.com>](mailto:c_justin76@yahoo.com), and the vanity name of case.justin.71. He was the administrator of the page, and he has made numerous posts harassing and slandering the Kemper's along with other employees and former employees of the City of Trumann. As of the time of this report it was discovered that there have been numerous posts on the public forum that have been removed recently.

I was able to confirm that the Facebook Profile case.justin.71, was a fake profile used to hide the identity of James Wayne Hickey aka Bo Hickey. Along with viewing the return of the warrant from Facebook, I discovered that Jackie Sanders, Heather Shrader, and Brandon Shrader were the main people that was using private messages to contact the page administrator (Bo Hickey) with information regarding Mr. and Mrs. Kemper, and making video, and photoshopping photos (Meme) of Kemper's, Barbra Lewellen, Scotty Jones, Chief Redman, and his wife Tara Redman. On March 1, 2020, Jackie Sanders met with the administrator (Bo Hickey) of the page at Jerry's Steak house and he (Bo Hickey) made Sanders the Editor of the page. A screen shot was sent to Sanders showing he was made the editor of the page and was told by Bo Hickey "done!! give em hell".

Soon after this meeting there was a profile created under the name of Michael Walt and was later changed to James

<https://www.facebook.com/michael.walt.5682> and the vanity name was michael.walt.5682. This profile was created on March 18, 2020, which was just days after Jackie Sanders was made editor. I then filed for and was granted a search warrant for the page and learned that email used to create the page was [michael.walt8266@gmail.com](mailto:michael.walt8266@gmail.com) [michael.walt8266@gmail.com](mailto:michael.walt8266@gmail.com) . I then filed for a search warrant for the GMAIL address and received the information on the GMAIL account of [michael.walt8266@gmail.com](mailto:michael.walt8266@gmail.com) [michael.walt8266@gmail.com](mailto:michael.walt8266@gmail.com) and learned that email attached to this GMAIL account that was linked to [michael.walt8266@gmail.com](mailto:michael.walt8266@gmail.com) [michael.walt8266@gmail.com](mailto:michael.walt8266@gmail.com) was [Jackie.l.sanders08@gmail.com](mailto:Jackie.l.sanders08@gmail.com) [Jackie.l.sanders08@gmail.com](mailto:Jackie.l.sanders08@gmail.com) which belongs to Jackie Sanders who is also part of the Trumann Chamber of Commerce and local business owner. Mr. Sanders then set up the account on Facebook and signed up for Facebook mobile on the same date. He then added the fake profile of Michael Walt on Facebook which has been identified as Bo Hickey. After this time Sanders began getting notification about The City of Trumann, Arkansas Page on who was commenting through this GMAIL account. Sanders also made numerous other accounts with other apps such as snapchat (mwalt4766) and The New York Times. On November 10, 2020 it appears that Jackie Sanders had changed his GMAIL profile name to that of "Beth Kemper" with his email [Michael.walt8266@gmail.com](mailto:Michael.walt8266@gmail.com) [Michael.walt8266@gmail.com](mailto:Michael.walt8266@gmail.com) ("Beth Kemper" [michael.walt8266@gmail.com](mailto:michael.walt8266@gmail.com) [michael.walt8266@gmail.com](mailto:michael.walt8266@gmail.com) ). The email continued getting notifications from The City of Trumann, Arkansas Facebook page to this account with the receiver as "Beth Kemper". It also appears he was logging into the Facebook Account under this "Beth Kemper" it is believed to make it look like Beth Kemper was behind running the page of The City of Trumann, Arkansas. He continued to receive notifications under the "Beth Kemper" name until May 24, 2022, where he changed EMAIL name to "James Kemp".

While reviewing the messages that Sanders sent to Hickey by messenger (private messaging) it was discovered that while Sanders was working for an EMS company as Helicopter pilot. On February 23, 2023, Sanders sent a picture to Bo Hickey showing him inside a helicopter with N number as N431AE telling Hickey he is "doing gods work". Hickey then messages under The City of Trumann Page asking if he was flying to or from NEA. Sanders advised he is dropping off at NEA talking about NEA Hospital. They then discuss the patient that was transported, and Sanders send a photo of the Patient with his face blacked out. The Photo depicted the patient inside the hospital room sitting on the couch in the room by the hospital bed. This is believed to be a violation of the HIPPA law.

After continuing the review of the page, it was discovered numerous posts that have been in public view along with private messages on Facebook had been removed or deleted. The harassment has continued since the page creations up to just about a month ago (June 2023). This department received notice from Meta Facebook that Facebook had notified the operator(s) of the page that a search warrant was served on the page and that is the reason for the post to slow down and completely stop. And it is believed this is the cause of wall post being removed. As of this date July 20, 2023, I have noticed that numerous public posts have been deleted from the page, but all information is preserved before it was deleted.

RE: Brandon Sharder:

Brandon Shrader had contacted The City of Trumann, Arkansas page in messenger (private messages) in the messages Brandon begins to talk about Mrs. Kemper and some HIPPA violation. Brandon advised that he was going to have his medication filled at the pharmacy that Mrs. Kemper was working at just to get her in trouble by making a false HIPPA violation complaint against Mrs. Kemper. They are talking about posting numerous posts on the page, just to upset Mrs. Kemper and Mr. Kemper.

#### **The Arkansas Justice Project:**

During the investigation, I discovered that Jackie Sanders and Heather Shrader had contacted a Facebook page named The Arkansas Justice Project. During the private messages sent by Jackie Sanders on February 15, 2023, he asked if he could give them information without using his name. Then he stated, "I can't publicly fight with these people because I have commercial assets in Trumann, and they are crooks that will retaliate" He began messaging about a residence burning to the ground and how the Trumann Fire Department response times are too long. He then messages about Revis Kemper personally in reference to incident RPS # 22-01088, Sanders made numerous statements that were not factual about the case. Sanders also made a claim that Revis Kemper's wife (Beth Kemper) had stalked his wife for months. I checked to see if there have been any reports about the stalking claim. Checking the past police reports it appears that it was never reported to any law enforcement agency in Poinsett County.

On February 12, 2023, The Arkansas Justice Project Facebook Page was contacted by Heather Shrader in reference to the incident involving Revis Kemper and his wife on October 23, 2023, RPS Case 22-01088. Heather advised the page that "the citizens" was paying for the appeal, which was a false statement from her. The Kemper's was paying for the appeal from their own finances. She also stated that body cam footage doesn't exist and that the officer turned his camera off. Which was also false. Shrader then continues to advise the page that the victims in the case had reached out to her and that and she filed Affidavits for the victim and "sent their affidavits to the prosecutor so they wouldn't be "lost" at the PD. The PD wasn't happy about that and told me to stop talking to the victims."

Heather Shrader continued to intervein with an open investigation and did not get the affidavit correctly notarized. (Refer to RPS CASE 22-01088)

She continued to make claims about the real crime is what the city did with FEMA reimbursement money from the

Tornado that hit Trumann. The entire conversation between Heather and The Arkansas Justice Project can be presented if needed.

**Conclusion:**

After investigating this case since February of 2023, it is believed that there is sufficient evidence to prove that James Wayne Hickey aka Bo Hickey and Jackie L. Sanders should be charged under the Arkansas Statue of 5-71-2015 Cyberbullying and Arkansas Statue of 5-71-209 Harassing Communications. The suspects in this case posted on these listed anonymous Facebook pages by knowingly encrypt their identity as to aid, assist, and encourage another person to commit the criminal offense and violated the Arkansas Law of Harassing communications and Cyberbullying. Both suspects used the internet and numerous social media platforms in an attempt to hide their identity so as not to be discovered that they were the ones that were posting and running the page of The City of Trumann, Arkansas. Due to the creation of the page "The City of Trumann, Arkansas", and the operation of this page, it has caused Mr. and Mrs. Kemper emotional distress along with the fear for their safety. The suspects had been the cause of numerous false statements and posted about not only Mr. & Mrs. Kemper, but numerous other employees/citizens of Trumann. There has been slanderous photoshop meme (pictures) created and posted on this Facebook Page that has since been deleted from public view. This continued harassment continued up till the time that they were notified that search warrants had been served on the accounts.

I am seeking an affidavit for a warrant to be issued for:

- James Wayne Hickey aka Bo Hickey DOB 10-07-1982
- Jackie L Sanders DOB 12/21/1989

The Arkansas statue of 5-71-2015 Cyberbullying reads as follows:

A person commits the offense of cyberbullying if:

- He or she transmits, sends, or posts a communication by electronic means with the purpose to frighten, coerce, intimidate, threaten, abuse, or harass another person; and
- The transmission was in furtherance of severe, repeated, or hostile behavior toward the other person.
- (c) The offense of cyberbullying may be prosecuted in the county where the defendant was located when he or she transmitted, sent, or posted a communication by electronic means, in the county where the communication by electronic means was received by the person, or in the county where the person targeted by the electronic communications resides.
- (d) (1) Cyberbullying is a Class B misdemeanor.
- Cyberbullying is a Class A misdemeanor if the victim is a school employee.

Ark Statue 5-71-209 Harassing Communications:

(a) As used in this section, "electronic device" includes a computer, cell phone, tablet, smartphone, or any other device that connects to the internet or is used in the electronic transmission of communication or information.

(b) A person commits the offense of harassing communications if:

- With the purpose to harass, annoy, or alarm another person, the person:
- Communicates with a person, anonymously or otherwise, by telephone, telegraph, mail, email, message delivered to an electronic device, or any other form of written or electronic communication, in a manner likely to harass, annoy, or cause alarm.
- Makes a telephone call or causes a telephone to ring repeatedly, with no purpose of legitimate communication, regardless of whether a conversation ensues.
- Knowingly permits any telephone or electronic device under his or her control to be used for any purpose prohibited by this section.
- Threatens by telephone, in writing, or by electronic communication, including without limitation by text message, social media post, facsimile transmission, email, and internet service to take an action against another person that is known by the person to be unlawful; or
- Places two (2) or more telephone calls anonymously, at an hour or hours known by the person to be inconvenient to another person, in an offensively repetitious manner or without a legitimate purpose of

communication, and by this action knowingly annoys or alarms the other person; or

- (2) With the purpose to frighten, intimidate, or distress emotionally another person, the person:
- Communicates by telephone to another person that a person has been injured, killed, or is ill when the communication is known by the person to be false; or
- Communicates with another person by any method described in subdivision (b)(1) of this section, without legitimate purpose in a manner the person knows, or reasonably should know, would frighten, intimidate, or cause emotional distress to a similarly situated person of reasonable sensibilities.
- (c) An offense involving use of a telephone or electronic device may be prosecuted in the county where the defendant was located when he or she used the telephone or electronic device, or in the county where the telephone made to ring by the defendant or the electronic device that received a message or email from the defendant was located.
- (d) Harassing communications is a Class A misdemeanor.

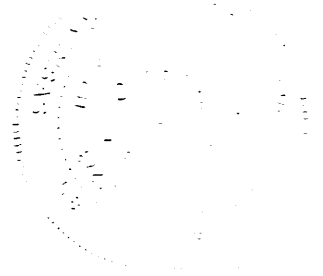

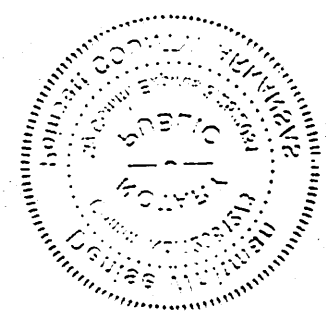

Trumann Police Department,

In light of recent events, I have concluded that legal action is necessary to stop the harassment of myself and my family by the "The City of Trumann, Arkansas Just for Fun" Facebook page, "Citizens for a Better Trumann" Facebook page, "The Arkansas Justice Project" Facebook page, Heather Shrader, Michael McWayne, and C.J. Laire. The individuals posting on these anonymous Facebook pages knowingly encrypt their identity to aid, assist, or encourage another person to commit any criminal offense and directly violate A.R. Code 5-41-204 (2019). The above individuals and pages are responsible for immeasurable emotional damage to my family and me. Their actions have caused physical damage to my property, as well as irreversible damage to my character and professional career.

Furthermore, Heather Shrader has continually harassed my family and me to the point that I believe it has become stalking. A.R. Code 5-71-229. Stalking (c) states, "A person commits stalking in the third degree if he or she knowingly commits an act that would place a reasonable person in the victim's position under emotional distress and in fear for his or her safety or a third person's safety." This harassment has occurred monthly for several years. Prosecuting attorney Thomas W. Haynes issued a letter to Heather Shrader to cease harassing communication per A.R. Code 5-71-209 in 2020. Heather has not only continued this harassing communication under the protection of anonymity but now has inserted herself directly into my personal life with false allegations against my family and me through a third party in direct violation of attorney Haynes's order. In fact, Heather attempted to use a forged affidavit document against me that The Trumann Police Department rejected.

"The City of Trumann, Arkansas Just for Fun" Facebook page administrators have continually harassed my family and me for 4 or 5 years. They have requested citizens to photograph my private property, edited pictures to depict me in an obscene manner, made videos depicting private citizens (my wife included) as Nazis, used obscene, lewd, and profane language against private citizens, and harassed public officials, city employees, and private citizens under the guise of anonymity and with the intent to cause emotional or physical damage. I believe Michael McWayne and Heather Shrader administrate this page. If Michael McWayne and Heather Shrader are not the administrators, then they are absolutely feeding this page false information with the intent to cause emotional and physical harm to my family and me. Also, in direct violation of Attorney Haynes's order.

Heather Shrader administrates the "Citizens for a Better Trumann" Facebook page, a known fact. This page has worked hand in hand with "The City of Trumann, Arkansas Just for Fun" and "Arkansas Justice Project" Facebook pages. Because Heather is the administrator and continually harasses my family and me through a third party, she directly violates Attorney Haynes's order. This fact further proves the intent to cause emotional and physical damage to my family and me under the guise of anonymity.

"The Arkansas Justice Project" Facebook page recently posted an article accusing me of using city property in an unapproved manner and even using bogus mileage numbers as a fact. They have also requested for people to follow me around and take videos. The misuse of property and mileage is entirely false. They interviewed with Region 8 News with completely false information and Bruce Ellis Taylor slandered my name on live television. They did so with malice and without any evidence whatsoever. It was a made-up story to cause emotional damage to me personally and character damage to me professionally. This story's damage is detrimental and irreversible to my future and career as a professional.

C.J. Laire has been following me for multiple years. He has made multiple Facebook posts and posted comments proving such. He has also published comments about which vehicle I parked in my carport, and he has followed me on occasion while I was in my personal vehicle. Yesterday afternoon, February 14, 2023, at approximately 10:00 am, C.J. Laire made a U-turn on Hwy 463 near Daily Dose Pharmacy and followed the Fire Department through the city. He then drove by several times while firefighters were performing their required physical fitness regimen at the gym. After work, I came home and switched to my personal vehicle to pick up my son from school. C.J. Laire then followed me while I was off-duty and in my personal vehicle to the school. After picking my son up, he followed me home and turned around on Reed Street near my house. This is an escalation from recent incidents. On March 5, 2020, my wife was blocked in our driveway by a parked vehicle. The person was there as a result of "The City of Trumann, Arkansas Just for Fun" Facebook page's request to photograph public officials' property. This person blocked my wife from leaving, causing her to fear for her safety, and a police report was filed. My personal vehicle was keyed, scratched, and had a sign hammered into the tire. I also filed a police report with the Poinsett County Sheriff's office for this incident. Police Chief Chad Henson was followed home by Johnny Kelley less than five years ago. That citizen then attempted to shoot and kill Chief Henson shortly after. These incidents have made me fear for my family and my safety.

I am filing this criminal affidavit against the above parties for harassment, stalking, and other crimes that you may see fit against my wife and me. It is not the victim's duty to investigate the crimes committed against them, nor does a victim have the means to investigate cybercrimes. There are thousands of comments and posts that I cannot screenshot or gain access to because I have blocked the individuals from my Facebook account in an effort to stop the attacks. I have provided several documents as evidence to best of my ability. The evidence provided will show the connection between the parties, fist hand admitters of administrators of the Facebook pages, prosecuting attorney cease and desist documents, and an attorney admitting that Heather was "Hellbent and a little too personally involved". These documents also show that the actions of the administrators of those pages have intentionally caused other individuals to commit crimes against my family and me.

The crimes that have occurred have escalated rapidly over the last few months, and I expect a full investigation into these crimes and their anonymous nature.
