On 6/16/2023 I was dispatched to [LOCATION REDACTED] to speak with [GRIFFIN'S WIFE] about a domestic that took place at [ADDRESS REDACTED]. While speaking with [WIFE] she stated Mr. Devin Griffin who she has been with for ten years got in her face on 6/16/2023 and began yelling and cursing her. [WIFE] stated she felt like he was going to cause physical injury to her as he has done in the past. She then went to [LOCATION REDACTED] and then called CCSO. Photo's of the past injury's from domestic's as well as the lethality screening and victim/witness statement form will be placed down below. I have no further information at this time.
