Narrative & Statements

Narrative - Chism, Levi - 6/17/2023 5:10:18 PM (Initial)

On 6/17/2023 at 1550 hours, I was dispatched to [SHARED HOME ADDRESS REDACTED] to in reference to a domestic disturbance. Upon my arrival, other deputies had already arrived on scene and had Arrestee #1 (Griffin, Devin) detained.

I spoke with Victim #1 [GRIFFIN'S WIFE] who stated that she and her husband, Arrestee #1 (Griffin, Devin), had been fighting since yesterday over text messages that she had received from a childhood friend. Victim #1 [GRIFFIN'S WIFE] stated that she had called police on 6/16/2023 and filed a domestic violence report. Due

to this, she stayed the night at a hotel. Victim #1 [GRIFFIN'S WIFE] stated that spoke with Arrestee #1 (Griffin, Devin) today and decided that she would come back home. Once home, Arrestee #1 (Griffin, Devin) was very cordial with her for the first hour even though he had been drinking. Victim #1 [GRIFFIN'S WIFE] advised that after she had been home, Arrestee #1 (Griffin, Devin), became extremely irate with her for no reason. Victim #1 [GRIFFIN'S WIFE] stated that Arrestee #1 (Griffin, Devin) began yelling in her face, putting his hands in her face, and told her that she could not leave. Victim #1 [GRIFFIN'S WIFE] then got away from Arrestee #1 (Griffin, Devin) and gathered her belongings. As she attempted to leave, Arrestee #1 (Griffin, Devin) blocked the doorway and took her possessions from her. It was at this time that Victim #1 [GRIFFIN'S WIFE] was able to contact the police. Arrestee #1 (Griffin, Devin) stated that she felt extreme fear for her safety and believed that Arrestee #1 (Griffin, Devin) was going to physically harm her and not let her leave [SHARED HOME ADDRESS REDACTED]

I then spoke with Arrestee #1 (Griffin, Devin) who stated that he had been arguing with Victim #1 [GRIFFIN'S WIFE] due to believing that she cheating on him. Arrestee #1 (Griffin, Devin) stated that he was extremely upset with Victim #1 [GRIFFIN'S WIFE] but assured me that he did not get physical with her.

Due to this, Arrestee #1 (Griffin, Devin) was taken into custody for Assault on Family or Household Member 3rd and False Imprisonment 2nd. Arrestee #1 (Griffin, Devin) was transported to CCDC and issued citations 0A0A0863251 and 0A0A0863251 with a court date of 8/15/2023 at 0900 hours.

A lethality assessment and Laura's Card were completed with Victim #1 [GRIFFIN'S WIFE]
